To pay property tax online, click the pay taxes link and follow the instructions. Master Card, Visa, Discover and American Express credit cards may be used for payment. There is an associated convenience fee to cover the cost of maintaining and supporting the system.

*Note: Taxes unpaid as of February 28 become delinquent and can no longer be made using this site. To pay delinquent taxes, go to the Wayne County Treasurer's Web site at

www.treasurer.waynecounty.com. Taxes transferred to Wayne County are subject to Michigan Public Act 123 of 1999 or (MCL 211.78) Tax Foreclosure.

IMPORTANT NOTICE

Beginning in 2004, the City of Detroit began collecting Wayne County taxes. Note that some are included on this summer bill in compliance with the 2004 State of Michigan Act 357.

Please mail your payment in enough time to reach the City by the tax due date. The postmark date will not be acceptable as evidence of timely payment. It is recommended mailing at least 10 business days before the due date.

Credit card payments are only accepted via Web site or by telephone. Please submit your payment in enough time to credit your account by the tax due date. Tellers at the Treasury office do not accept credit cards. To pay taxes online follow the instructions detailed above or use www.officialpayments.com. To pay by telephone, call 1-800-2pay-tax (800-272-9829), jurisdiction code #3279
